Project Truth

Project Truth will visit the Santa Rosa campus on April 24th & 25th, from approximately 9:00 am – 2:00 pm on each of these days. They intend on conforming to the college's free speech guidelines regarding "time, place and manner" throughout their demonstration. We have suggested they be located in the Bertolini Quad so that their activities can be closely monitored. At this time, it does not appear that they intend on visiting the Petaluma campus or any other district site. Project Truth is a mainly conservative evangelical organization that is devoted to opposing abortion rights. When they have come in the past, there have been peaceful, student-organized counter demonstrations, and organized discussions by instructors of, for example, critical thinking classes. We always warn the college community when they come because they have a strategy of trying to provoke strong emotions and make their money by suing people of free speech violations. For many the wisest course of action may be just to steer clear of them. But there is nothing wrong with engaging them in a calm discussion, and rebuttal if you have a mind to, of their views. They are trained to be on their best behavior. Personally, I can't resist talking to them.
