Resolution of No Confidence in Chancellor Oakley

The Santa Rosa Junior College Academic Senate

Adopted September 5, 2018

Whereas, The Chancellor of the California Community Colleges and his office has pursued an agenda to reform the system, an agenda that we affirm is noble in its focus on student equity and is born of valid concerns, but one which is undemocratic in its method, including, but not limited to the Vision for Success, The Fully Online Community College (FOCC), a new, partially completion-based funding formula, legislation such as AB 705 and AB 19, which have the accumulative effect of implementing the Guided Pathways framework by means of financial coercion rather than collegial consultation,

Whereas, The Chancellor of the California Community Colleges has failed to consult collegially in an authentic way with the Academic Senate for California Community Colleges, or otherwise include faculty in decision making, in spite of the Academic Senate's designated primary role in recommending policy on academic and professional matters in law (AB 1725), as well as Board of Governors policy (BOG Standing Order 332),¹

Whereas, Although the Chancellor and his office have disingenuously claimed to have obtained faculty buy-in for the above named reforms, in fact the Chancellor and his office have proceeded to implement these against strong virtually unanimous faculty opposition, for example the FOCC, and or widespread critique, for example, The Vision for Success, employing a strategy that may be characterized as the "Illusion of Inclusion," and

Whereas, The Chancellor has dismissed faculty opposition as being, for example, based on discontent with labor negotiations without acknowledging that much of the opposition comes from Senate, rather than union, leadership, and not the result, as falsely claimed, of organized union agitation, but of grass roots faculty professional concerns,³

Whereas, The Chancellor has usurped local college districts' rights of autonomy in shared governance processes by demanding Boards of Trustees to align their colleges' mission with the Vision for Success as a condition for funding,
