The faculty has the traditional right of college faculty to participate in the governance of the College. As specialists in specific disciplines and as experienced instructors, the participation of the faculty in the governance of the College is essential for the District's pursuit of its mission. As professionals, the faculty has the right and a duty to set professional and ethical standards for the conduct of their profession and to promote the excellence of their profession. In order to achieve these ends and in accordance with Title 5 of the California Administrative Code, Subchapter 2, Sections 53200-53205, this Academic Senate is established.
