**In previous years, SRJC annual changed its institutional-set standards to represent moderate increases over accomplishments from the previous year. As a result, SRJC had institutional-set standards that fluctuated in the categories of certificates, associate degrees, and student transfers. After careful review, SRJC determined that fluctuations in institutional-set standards represented more of an aspirational goal than an institutional minimum standard.**

**The 2020-21 Annual Report presents new institutional-set standards for certificates, associate degrees, and student transfers. The new institutional-set standards represent our minimum expectation for certificates, associate degrees, and student transfers. Additionally, SRJC has established aspirational goals that represent the college's goal to continually increase successful student outcomes.**

**One area of note, the institutional-set standard for certificates represents a 6-year historical trend**

which excludes outliers. Over the past two years, SRJC has experienced a significant increase in the number of certificates awarded to students. One suspected factor to this increase is the number of IGETC and CSU certificates earned by SRJC students. SRJC plans to monitor our number of earned certificates and readjust the institutional-set standard within the next two years.
