Work continues on a lot of business, but I'll be using the lion's share of my time today for things other than business. Regarding the governance redesign project, College Council will be doing as much as possible before the end of the semester, and then I'll work with Vice President Saldana-Talley to synthesize and summarize that work so that it is in good shape for handing off. The Faculty Equivalency Committee will meet one more time, this Friday, to further our work on improving our processes. And the Educational Planning and Coordinating Council reviewed additional policies and procedures that are on today's Consent agenda for Senate consideration; additionally, EPCC has improved its process for review of policies, procedures, and new programs and is ensuring that their work comes to Senate in the form of recommendations for Senate consideration. Strategic Planning will continue in the Fall, and the Academic Senate President will continue to be involved.

The College is looking forward to revising its Educational Master Plan next year, and the Senate will have a strong role in that. Next year will also bring work on a Student Equity Plan, and I hope to see the Senate and the faculty have appropriate roles in that work.

Finally, regarding students' preferred pronouns, there is some urgency about this, and it will be on the August 17 agenda, either as a Consent item or a Discussion item marked urgent, so that, assuming Senate support, the question can be determined at a single meeting.

It's always special to be able to welcome new life. Congratulations to Senator Kat Valenzuela and former Senator Mark Ferguson on the birth of their son, who was born on May 6.
