- 1. What Shall Be the Academic Senate Recommendation for Area 6 Curriculum in the New CAL-GETC Pattern? (15 min)
 - 1st Choice of Action (Ethnic Studies Department Recommendation as of 10/11/24): Follow the intent of Cal-GETC Area 6 Ethnic Studies and only allow courses that have been approved at the CSU/UC level Ethnic Studies [ES] in autonomous disciplines within Ethnics Studies (ES).
 - 2nd Choice of Action (Revised Recommendation from Curriculum Office based on Previous Senate Discussion): Allow only courses approved at the State level for Cal-GETC Area 6 to be a part of our local Area 6 curriculum, and utilize the support of the local CRC processes, systems, and bylaws (see also page 7, Article Vii, Section B) to enable the expansion of Area 6 (locally and Cal-GETC) while also maintaining the essential elements of the Ethnic Studies curriculum.
