The Question in front of the Senate today (2 April 2025) is...

As resulting from the direct consultation of the District Online Committee, does the Academic Senate recommend that the District extend our license with Proctorio through the next academic year so that it expires in June of 2026?

RECOMMENDATION FROM DISTANCE EDUCATION

DE recommends that the District extend our license with Proctorio through the next academic year so that it expires in June of 2026 (**Option 2** below).

LICENSING AND COST

Our current license for Proctorio expired in February. We have two options if we want to renew this license:

- Option 1 is to pay for a prorated year to align our service contract with statewide software terms. The cost would be \$3,437.00 to provide service until the end of June: \$14 per user per year (\$6.25 for 4 months) for 550 users.
- Option 2 is that Proctorio will provide us 4 months of free service if we agree to renew for another fiscal year under the statewide STAC agreement. The cost would be \$4,950.00 for 2025-26: \$9 per user for 550 users.

SUMMARY

The District currently licenses Proctorio, an online proctoring software platform, and <u>our license has</u> <u>expired</u>. Two other companies have developed competing products that Distance Education staff believe to be worth considering. We have reached out to faculty users of Proctorio for their input, and have brought the issue to the District Online Committee (DOC) for a recommendation. A comparison of the three products was created and is attached, and individual faculty feedback can be found below, as well

as additional details about the situation. The recommendation from Distance Education is to continue the current Proctorio license until further discussion can take place.

RELEVANT ISSUES

- 1. Some academic programs require that online classes have proctored exams in order to be in compliance with outside accrediting or licensing regulations.
- 2. Increasing concerns over AI and academic integrity may increase demand for online proctoring software.
 - a. Given the current ease of access to such tools, it may be unrealistic to tell students that they may not use AI to complete an assessment, but then do nothing to prevent them from using it. This is especially true for online classes.
- 3. Proctoring software uses AI to monitor student exam videos, which raises security/privacy concerns for students.
- 4. SRJC could consider alternatives or additions to proctoring software (such as Zoom proctoring or scheduling online courses with in-person or scheduled online exams). This would offer faculty more flexibility in determining strategies to deter cheating.
 - a. Remote proctoring (at a local public or college library or assessment center) may be possible for students who cannot come to campus.
- 5. Providing these types of alternatives might require SRJC to reconsider our current list of modalities. For example, an asynchronous course that requires specific times for an online or inperson exam is currently identified as "synchronous" or "partially online" in the Schedule of Classes. This likely causes some confusion for students who may mistake these largely asynchronous classes, for synchronous ones with weekly scheduled meetings. In addition, some faculty might be more willing to offer online courses if they had more control over how the exams for those courses were delivered.
- 6. Providing ways for faculty to proctor their own exams on-campus may require additional space and staff. Providing more support for faculty to proctor their own exams via Zoom might require TAs (depending on the class size), so that the exam can be properly monitored.

Current Proctorio Usage Data

- 13 instructors
- Departments: Chemistry, Biology, Astronomy, English, Economics, Spanish, Philosophy, History, Horticulture, Emergency Medical Care
- Approximately 550 students per year, with the prediction that this will soon be 600
