Student Success Coach Pilot in Statistics hybrid math courses. QuickStart templates for faculty. 106 CA community colleges now using Canvas of which two are live in the OEI Course Exchange. (DOC in role as advisory committee) [Committee Function 2] CCCCO Distance Education Student Satisfaction Survey – SRJC will participate in the California Community Colleges Chancellor's Office (CCCCO) statewide online student survey including 5 local questions.
