CALL TO ORDER:

The meeting was called to order at 3:16 p.m. by President E. Thompson.

OPEN FORUM:

1. Tara Jacobson provided concerns with focus of the Senate:

- Senate should guide 10+ 1 matters and present to the Union but feel that the process is reversed.
- Negative tenor and tone of the Senate
- Discussions increasingly informed by AFA working conditions which is not purview of the Senate
- Discussions are not leading to concrete actions and decisions; seen in topics returning over and over again without any conclusion
- ONOT All voices in the Senate are speaking up
- Senate Executive Committee is making decisions without consulting the Senate body
- Faculty on subcommittees are doing work, presenting work to Senate, and not receiving support; micromanaging appears to happen on the Senate's part; feelings of lack of trust and respects happen on the faculty's part; Exec Senate needs to trust committees.

2. Laura Larque provided concerns with Senate trust in FFAS committee:

- ♦ Frustrations are present by the Senate and the FFAS committee
- Diversity/Equity category in the rubric should be addressed openly

3. Regina Guerra provided concerns about Equivalency committee:

 Delay in applications and actions outside of purview of committee causing lost loaded income and months of waiting by adjunct faculty.

- Guided Pathways
 - <u>The Scale of Adoption Assessment (SOAA)</u> was submitted last week
 - Organized into pillars and practice
- Faculty Diversification
 - Ourrently the number one priority of the ASCCC
 - Adjunct are less diverse than full time but full time faculty are the only one's counted so far. We have made significant progress but more to go.
 - Other on President's report (link above) that shows SRJC full-time, adjunct, and administrator numbers compared to county numbers which show that Latinx and African Americans remain significantly underrepresented.

DISCUSSION:

- 1. Board Policy 4.3.2/P, Faculty Hiring: Regular and Adjunct –Senate Executive Committee (A Donegan)
 - Context of the policy was updated and passed by the Academic Senate in 2018, but the policy was never presented officially to the board and approved. Both a marked-up and clean versions of the policy are available for review. It would take 2/3 Senate vote to amend the 2018 policy.
 - Discussion:
 - ♦ "Straw" voting continued on individual changes from <u>Comparison Document</u>
 - Straw voting is unofficial voting to see what the Senate body wants
 - Item III.3: majority wanted to change wording to "allow for adjunct member to serve on committee as long as that member does not possess a conflict of interest"
 - Item III.4: majority wanted to allow students to participate in hiring committees but not as voting members with access to confidential information or in the entire process of the hiring committee.
 - ◊ The majority wanted item IV.1 changed
 - ◊ The majority wanted item IV.2 changed
 - This item will be brought back for further discussion.

2. Faculty Fund for Advanced Studies (FFAS) Rubric – N Persons

- FFAS Grant Application are now competitive due to increased demand.
- N Persons presented <u>new rubric</u> by paper
 - Rubric was based on direct feedback and consultation with senate faculty, specifically John Stover
- Discussion:

- Senate wanted Criterion 2 removed "Meets all of the section 5 criteria identified in guidelines"
- Senate wanted "below average", "average" and "above average" replaced with "vague statement", "1 example given" and "2 or more examples given"
- Senate voted to approve by Roll Call. 22 members present: 21-Yes, 0-No, 1-Abstain
 Approved
- 3. Sustainability Committee S Jones
 - Sustainability committee would like the Academic Senate's support for their <u>Climate</u>
 <u>Resolution</u> and <u>Plastics Resolution</u>
 - Resolutions will be taken to the Board for approval
 - Senate voted to approve by Roll Call. 21 members present + 1 proxy: 19-Yes, 0-No, 2-Abstain
