Dr. Chong is not able to join us today and asked me to wish you all happy holidays.

I'd like to thank Senator Aspinall for covering for Secretary Stover, who is out today.

On Wednesday, December 8, we partnered with Kate Jolley, Vice President of Finance and Administrative Services, to host a meeting with a representative from the company that makes the Program Mapper software. Recall that moving forward with exploring this software was on the Senate's November 17 Consent agenda. On Monday of this week, we had a follow-up meeting so that attendees could discuss the product and recommend on next steps. Thanks go to those who attended the product demo and the discussion, and particularly to Kate Jolley for prioritizing and fast-tracking this process.

Those of you who were on the Senate last year may recall that we did some foundational work on how departments are allocated among the 13 Areas of representation. We were not able to agendize that last academic year and had hoped to do it this fall, in advance of launching the Spring 2022 election cycle for terms that will begin with the Fall 2022 semester, but this semester is getting away from us, too. Please note that we'll be posting the census information so that everyone can be aware of where things currently stand.

At Plenary, two colleagues from the Los Rios community college district led a presentation on their work to weave equity into their faculty evaluation process. Several of us who attended Plenary really appreciated the work that was shared by these two colleagues—Belinda Lum, the chief negotiator for the faculty union, and Julie Oliver, a past president of her local Academic Senate. We are hoping to host a workshop with Professors Lum and Oliver so that SRJC faculty members can hear about their work. They've expressed willingness to participate in a virtual workshop next spring, and I hope to announce a date soon.

One item that we expect to see on an upcoming Senate agenda is the question of how to resolve conflicts over placement of courses within disciplines. The Curriculum Review Committee (CRC) has a process for placement of courses, and sometimes there are conflicts among faculty members in different disciplines. CRC has discussed the question and will be forwarding a recommendation, which the Senate will be asked to consider.

As a reminder, we have two upcoming training sessions with members of the ASCCC's Executive Committee. On January 24 Stephanie Curry and Michelle Bean will be talking with us about DEIA and 10 + 1. Several Exec members met with Stephanie and Michelle for a planning meeting last week, and we will be in good hands. And on Friday, February 11, for the last hour and a half of our spring retreat, we will meet with Cheryl Aschenbach and LaTonya Parker, who will be presenting on Minimum Qualifications and Equivalency for Ethnic Studies.

When we return in the Spring, we'll be formally launching our Strategic Planning process. Thanks to Dr. Jeremy Smotherman for being such a joy to partner with on this project. Please watch for invitations to the series of Strategic Planning Town Hall meetings that are scheduled for second and fourth Fridays next semester. Those who are unable to attend will be invited to share ideas and feedback via online surveys. The SP process is an opportunity for us to collaboratively shape our college. I encourage everyone to participate as they are able.
