Strong Workforce Recommendations: Curriculum

Asking for curricula portability in CTE industry. C-ID course identifier system to articulate across institutions.

Workforce funds can be used to hire faculty, tenure track positions. Go through local processes.

Develop a website repository of CTE model curricula that faculty and colleges can select and adapt to their own needs.

CTE leadership committee at ASCCC make sure CTE is responsive and aligned to current and emergent industry trends, also ensures similar courses programs and degrees are portable among community colleges.

Expand CTE faculty in leadership roles in local, regional, and statewide levels through its ongoing professional development.

Efforts to create CTE liaisons at local academic senates. Spring 2015 resolution passed 17.02 urging colleges to designate a CTE faculty liaison to facilitate communication. One faculty per campus. Currently, 62 colleges with active CTE liaisons.

Chancellor's office message is to plan as though this funding is permanent.

Meta Majors cluster areas that are similar, so students can see different options. Ask faculty and students about creating these meta majors. Dialogue between counselors and faculty is very productive in this process.

Make colleges ready for students vs asking if students are college ready. Does not limit student choice rather than guides them make informed choices. Faculty driven process.

<u>IEPI Update: Indicators, PRTs (partnership resource teams), and Professional Development</u>

Help colleges enhance student access, success, and equity Avoid accreditation sanctions and audit findings Support in implementing current initiatives

Indicators:

Student Achievement Fiscal Stability State and Federal Programmatic Compliance Accreditation

Indicators: looked at Student Outcomes, Accreditation status, fiscal viability, state and federal compliance, other (optional college choice). Had to set goals around required some areas.

Upcoming indicators:

- 1. Transfer level Math/English completion rate year 1 and year 2.
- 2. Number of low unit certificates
 - Less than 18 units (including non-chancellor approved)
- 3. Median time to degree
 - From first enrollment in a CCC until they receive AA/AS/ADT
- 4. Number of CDCP Awards
- 5. Noncredit Fill in the blank (each college makes their own goal)
- 6. CTE skills builder
 - Median % change in wages for student's who completed higher level CTE coursework and left the system without transferring to a four-year or completing degree or certificate. How is this measured?? Wages before an after they left? Chancellor's office merging data with EDD employment development department.
- 7. Access: District Participation Rate for 18-24 year old population
 - % within district boundaries that are enrolled in a CCC in that district
- 8. OPEB (other post employment benefits) liability

- Self reported % of OPEB liability that includes retiree benefits (medical, dental, Rx, Life, long term care) and can include funds from either a trust and outside of a trust designated for this liability.
- 9. Non-credit course success rate, only those reporting grades for non-credit How do you set goals for these??

Meaningful dialog with campus community, connected plans and initiatives at the college, don't just add 5 percent blindly, no punishment if you don't achieve your goals, Goals can be lower, no sanction for not achieving goals.

PRTs (partnership resource teams)

Process begins with CEOs short letter of interest which identifies areas of focus for assistance. \$200,000 along with it.

Each PRT commits to at least 3 visits designed to:

Understand issues and identify scope of support

Provide options for consideration by the institution in its innovation and effectiveness plan to address its areas of focus and advise in development in plan.

Follow up with advice and guidance on early implementation as needed

Mini-PRT \$75,000 smaller issue

College Promise in California

Jan 2015, Obama unveiled America's College Promise proposal: Tuition free community college for responsible students – **America's College Promise Act of 2015**

First two years of college free for students willing to work hard.

Pay fees and tuition for "hard working" students. Each program defines what criteria for responsible hard working student.

Sept 2016 Gov Brown approved CA College Promise Innovation Grant Program – 15 million dollars. BOG is a "Promise Program". 23 Promise programs in CA, more on the way....
