- **2. "Three New GenAl Features Debuting in Canvas" (15 min)** This item appeared as an Information item at our August 20th meeting, and a senator made a motion, which was seconded, to move the item to the Discussion Agenda of this meeting. It was difficult to frame a specific question to be discussed based on the following factors as discussed by the Academic Senate Executive Committee:
 - It is not <u>Senate 10+1</u> purview to debate the merits of Generative Artificial Intelligence writ large.
 - The Academic Senate has, on a very limited basis, taken up the debate of Canvas-based teaching tools, and to do so now would be precedent setting in a manner running counterintuitive to an Instructor's academic freedom of choice in their teaching and learning activities.
 - AFA has established the need to negotiate with the District, which is forthcoming.
 - The District has made the call for the formation of the Generative Artificial Intelligence
 Taskforce, which is a direct result of <u>an Academic Senate recommendation</u> in Spring 2025 (also see minutes of April 30, 2025)
 - A subcommittee of the <u>Educational Planning and Coordinating Committee</u> (EPCC) <u>as per AP2410</u> is working on <u>an academic intregrity policy as reported out on May 7, 2025</u> and as recommended by the Academic Senate on February 19, 2025 (<u>see minutes here</u>).
 - The three faculty-facing GenAl tools proposed for Canvas by Canvas and Instructure have to be activated, one by one, by each instructor if they wish to use them in any combination (i.e., these are opt-in tools).

With this in mind, the Senators who made the motion and the second to move to Discussion will be called upon first to speak to the topic.

3. Online Teaching Certification (30 min) Does the Academic Senate wish to adopt the recommendations embedded in the Faculty Online Teaching Certification Work Group Final Report [May 7, 2025] as including (but not limited to) the following:

Recommendations re: Certificate Basics.

- 1.1 Therefore, WE RECOMMEND that SRJC's Distance Education department create a custom Online Instruction Certification (OIC) that aligns with <u>@ONE CVC-OEI Course Design Rubric</u> in legally relevant materials such as Interaction, and Accessibility, while also providing training in content presentation and assessment.
- 1.2 WE RECOMMEND that SRJC's OIC should be at least 40 hours (which is the current length of the existing Online Special Expertise (OSE) Certification program) to achieve @ONE alignment in legally relevant materials, such as Interaction and Accessibility.

- 1.3 WE RECOMMEND that when a department does not have any available certified faculty, the department chair, in consultation with the ID, can assign an online course to a non-certified faculty or new hire, who must then enroll in the full certificate course.
 - 1.4 WE RECOMMEND that the certificate should be approved for FLEX and PGI.
- 1.5 While matters of pay are out of our purview, WE RECOMMEND working with AFA as appropriate to achieve a similar or monetary incentive for all faculty, especially those who do not qualify for FLEX or PGI, such as online associate faculty.

Recommendations re: Certificate Updates.

2.1 WE RECOMMEND that Distance Education track faculty certification status, new regulations, and any recommended @ONE aligned updates, and will report any relevant information to the Academic Senate and DCC/IM on a regular basis, such as once a year. Any changes that could affect the time commitment of the SRJC certificate will be communicated to the Academic Senate as soon as possible [footnote: It is also worth noting the @ONE OEI Rubric will be updated in the future and will likely have an additional component to address Equity and Inclusion, which could be addressed at that time.]
